REQUIREMENTS FOR 9(A) TEMPORARY VISITORS VISA

A. For countries whose nationals are required to secure a visa

1. Business

- applicant's national passport valid for at least six (6) months from date of arrival in Philippines
- company letter-request stating applicant's position, purpose of trip and guaranteeing his financial support
- 1 latest passport size photograph
- application form
- applicant must come personally

2. Tourist

- applicant's national passport valid for at least six (6) months from date of arrival in Philippines
- round-trip or onward air ticket to other country of destination and/or itinerary of travel duly issued by an authorized travel agency in Singapore
- proof of sufficient funds for travel expenses, accommodation and subsistence
- one (1) latest passport size photograph
- applicant must come personally

NOTE: In the case of applicant from Taiwan two (2) application forms and two (2) photographs should be submitted.

B. Nationals who are required to apply for a Philippine visa from their country of origin will not be issued visa unless they can present proof that they are legal resident in Singapore (PR, EP, WP, student, etc.).

C. Nationals of countries who are allowed entry without visa for 21-day stay must present at the Immigration Control of the Ninoy Aquino International Airport in Manila or other ports of entry, the following:

- passport valid for at least six (6) months from date of arrival
- round trip ticket or onward ticket to next country of destination

Submission: 9:00 A.M.-12:00 noon
Monday to Friday

Releasing: 4:00 P.M.-5:00 P.M. the following day

NOTE: Payment for the visa should be in cash and not in the form of a credit card, nets or check
